



# Do Pipelines Benefit Pennsylvanians?

A report prepared by Key-Log Economics for the Sierra Club in connection with the proposed Atlantic Sunrise pipeline shows little economic benefit to Pennsylvania and enormous ecological damage. Key-Log Economics explains the true costs of the Atlantic-Sunrise pipeline, finding that proponents overstated the pipeline's economic benefits while FERC discounted or ignored some of its environmental costs. These costs include the effects of the pipeline on property values, the diminished value of ecosystem services, economic damages associated with increases in greenhouse gas emissions, and public health costs due to the release of toxins and smog-forming pollutants.

The Atlantic Sunrise pipeline runs North-South from Susquehanna County to the PA-MD border. The project would clear cut its way through eight Pennsylvania counties, impacting 2,000 acres of forested land and crossing hundreds of wetlands and water bodies. The proposed route includes nearly 200 miles of new pipeline in Pennsylvania. This pipeline would transport gas for export overseas.



## Pipelines, continued from page 1



The report estimates the pipeline's total costs to the environment (the initial cost plus the discounted value of all future annual costs) at between \$21.3 and \$91.6 billion. The annual cost associated with the social cost of carbon from the project's greenhouse gas emissions would be \$2.3 to \$3.5 billion per year. One-time costs (during construction) for lost ecosystem functions, such as wetlands filtering, tree cover, and flow control, are estimated to be \$6.2 to \$22.7 million. Annual costs for this diminished ecosystem would total approximately \$2.9 to \$11.4 million per year.

Although the pipeline may create some temporary construction jobs along the pipeline route, the pipeline only creates 29 permanent jobs and \$1.8 million in new income resulting from the operation of the project per year. These figures include 15 direct jobs and spending necessary for operation of the pipeline itself. This is a miniscule benefit for a claimed \$2.6 billion project. When pipeline advocates claim great economic benefit for Pennsylvania from these projects, we rightfully should be skeptical of their touted figures.
