

As we approach a new climbing year, we should consider the need to hone our skills and techniques at navigation, rock climbing, snow travel, and stream crossing. Safe, efficient, and enjoyable pursuit of goals in the mountains is facilitated by proper skills and conditioning. Now is the time to plan to attend the training exercises which provide opportunities to sharpen nav, rock, and snow skills.

A new set of federal regulations on the issuance of wilderness entry permits to groups and/or organizations is being implemented (particularly by the Inyo Ranger District). We do not expect the changes to impede our ability to provide a variety of well-led trips for our members and guests. We are still trying to get clear definitions but it now appears that the Angeles Chapter will obtain a special use permit. Individual outing permits would be issued under that permit. All of this is subject to Angeles Chapter approval and Forest Service acceptance of our application. When filing wilderness entry permit applications for SPS scheduled trips note that they are trips for the Sierra Peaks Section of the Angeles Chapter of the Sierra Club. Also note that participants pay no fees.

### WILDERNESS ADVANCED FIRST AID REFRESHER

### HARWOOD LODGE SNOWCREST

17-19 May 1985 (Fri. evening - Sun. afternoon)

This course emphasises first aid problems likely to be encountered in the wilderness. It is conducted under the auspices of the American Red Cross, and an Advanced First Aid certificate renewal will be presented upon the successful completion of the course. The problems associated with long term care and transport of the sick and injured, and the special problems of high altitude, cold, heat, dehydration, and exhaustion are studied. Some practice working on "victims" and a practical field exercise are included in the course. Participants must review their CPR and demonstrate their skill on a Recording Annie mannikin.

The instructors have had experience in mountain rescue, Sierra Club, scouting, expedition work, and other group leadership activities and have personally encountered many of the problems likely to occur. Guest lecturers

will present material in which they have special expertise.

Harwood Lodge, owned by the Sierra Club, is located high in the San Gabriel mountains several miles above Baldy Village. It has sleeping facilities for over 50 people, however, many individuals prefer to spread their sleeping bags outside. Registration fees cover lodge fees and dinner Saturday night, breakfasts Saturday and Sunday mornings. BRING LUNCHES FOR TWO DAYS. No alcoholic beverages, radios, or pets allowed in the lodge; battery-operated tape recorders are welcome. The course starts promptly at 8:00 pm Friday night.

Anyone interested may attend this course, however, preferably one should have had a previous first aid course. A current Advanced First Aid card must be shown for recertification. (no CPR certification) Send application and \$30.00 to: Wilderness First Aid

WILDERNESS PERMIT RESERVATION FEES Notice from the Federal Register Vol. 40 No. 222, Nov. 15, 1984

Dept. of Agriculture Forest Service 36CFR part 291 Agency: Forest Service USDA

Action: Proposed Rule

Summary: The Dept. of Agriculture proposes regulations to recover costs associated with administration of user reservation systems on some National Forest System recreation areas. This action is necessary to continue protection of resources and protection of high quality recreation experience.

NOTICE WILDERNESS PERMIT APPLICANTS

NOTICE

A notice of proposed policy on issuing and administering outfitter/guide special use permits was published in the Federal Register in April 1983. The Angeles Chapter was not alerted to this proposal and we are told that the National Sierra Club does not receive the Federal Register nor read the thousands of proposals, notices of decisions, filing of petitions, rulings etc that annually appear in the Register. On February 15, 1984 the Forest Service adopted new policies concerning the issuance and administration of outfitter/guide permits. In the past, special use permits (SUP) were issued if the permitted activities in the National Forest were of a commercial nature. Now, because of the increased amount of legal activity resulting in added exposure of everyone in our society to legal actions and liability suits (examples in a National Forest: proper maintenance of trails so hikers do not get lost or injured; granting a wilderness permit to a GROUP [such as church group, YMCA, scouts] when perhaps the leader has no training or experience in the mountains; inability of the Forest Service to always perform a rescue in such situations; etc), all use of the National Forests will now require a SUP. The lnyo National Forest is the first (and probably not the last) to require this SUP for non-commercial group trips into the National Forest.

Non-commercial organizations which require this SUP include church groups, youth groups, fraternal groups, educational institutions, conservation groups and many others. SUPs will be granted to groups who have liability insurance which names the National Forest as co-insured and to those groups which meet the National Forest's minimum suggested outfitter/guide (leader) qualifications. The Angeles Chapter already meets both these qualifications.

There is a fee involved in getting a SUP which is based on the outfitter's adjusted service-day client charge. Adjustments which are excluded from the fee base include long distance transporation and lodging, the percentage of supervised time spent not in the National Forest etc etc, too complex and unknown to understand completely at this time.

ANYWAY, the Sierra Peaks Section trips that I know anything about in the last 25 years, because we "make no profit, receive no reimbursement or salary, rental for use of animals or equipment, nor support other programs from amounts received from participants..." and many other Groups, Sections and Committee trips into the National Forests will be granted a outfitter/guide special use permit (SUP) where the fee will be waived and there will be NO charge.

At the Angeles Chapter Executive Committee meeting on January 17 Elden Hughes, the Chapter Chairman, announced that the Angeles Chapter has applied for an outfitter/guide SUP covering all Chapter activities such as all SPS, DPS, HPS trips and activities of many other groups, sections and committees which qualify as exempt from SUP fees. Elden will present this proposal to the Angeles Chapter Council under Chair Art Blauvelt on January 28 and it will be studied by members of the Chapter

Executive Committee before the application is signed.

Those Chapter activities inside the National Forests which perhaps do not fall under the non-fee category are still under study and very likely will be covered by a separate special use permit where there will be a fee involved.

WHAT THIS WILL MEAN TO US IS THIS: There will be <u>nothing</u> additional which leaders or participants will have to do for us to be covered under this Angeles Chapter non-fee "blanket" SUP if it is adapted.

What we should do, and the purpose of this NOTICE, is this: when we apply for our <u>Wilderness Permits</u> in the Inyo National Forest (the Lone Pine, Bishop or Mammoth Lakes offices) and actually it would be safe to follow this recomendation when applying in <u>any</u> National Forest on and after March 1, 1985, where the permit application asks, "Organization/Group Name" we must state ANGELES CHAPTER, SIERRA CLUB. If we are operating under the SUP in question this identification, together with the appearance of our trip in an official Chapter publication will give us coverage under the non-fee SUP. Even if we qualify for this SUP we <u>will still</u> apply for our Wilderness Permits <u>just as we always have</u>. —Ron Jones

OCTOBER 1984

Don Weiss served his famous guacamoli, and others contributed other fine goodies so that we almost did not have to fix dinner.

Susan Hanna and Jay insisted on taking a bath in the dry creek, so they almost missed the happy hour.
