Coral smothered by sediment

In September, the Broward Sierra Club, and over a dozen businesses and environmental organizations joined Miami Waterkeeper and the Center for Biological Diversity in demanding that the Army Corps of Engineers reevaluate its Port Everglades expansion plan in light of the impacts to Miami's reef during its recent port construction. In a 15-page letter, the groups detailed

the Corps' multiple failures to protect coral reef resources during the Port of Miami Deep Dredge Project - how hundreds of acres of corals were smothered, and how "lessons learned" have not been incorporated into plans to expand Port Everglades. Since receiving this document the Corps was forced to postpone the dredging of port Everglades in Fort Lauderdale for at least six months. Luckily for us, this postponement brought us into turtle season when dredging cannot be done, since it would interfere with the nesting of sea turtles on Broward County beaches, which includes port Everglades. As of January 20, we have not received a response from the Army Corps of Engineers to our complaints in this letter. (You can read the entire letter at http://tinyurl.com/PortEvergladesLetter.)

Touted as an environmental breakthrough, the water-policy bill passed last week by the Florida Legislature is actually a major win for polluters and the politicians they own. Again, the Florida legislature has rewarded big agriculture, ranchers, and the sugar industry. Enforcement of cleanwater rules is being replaced by the honor system. And you know what that means. The polluters will continue to pollute, and we the taxpayers will be forced to pay to clean up the messes they create.

Finally, some good news for us in Broward County. Commissioner Beam Furr has sponsored an ordinance to prohibit extreme well stimulation for purposes of resource extraction ("fracking") amending section 27-193 of the Broward County code of ordinances ("CODE"); and providing for the Severability, including in the code, and an effective date. This legislation will be brought up for a vote on the Broward County commission meeting on Tuesday, January 26, 2016.



FEB. 27, SAT. HIKE BIG CYPRESS NATIONAL PRESERVE. We'll hike approx. 6-8 miles on a wilderness trail, off a section of the Florida National Scenic Trail, north of Alligator Alley (about an hour from downtown Ft. Lauderdale). You'll learn the difference a few inches of elevation makes to the local flora, as you trek through cypress forests, hammocks and prairies. And many northern states, especially in New England, are already ahead of us in promoting solar panel usage.
