
Hi all!

Neither house of the Arizona Legislature was in session this week, so no bad legislation advanced. The Senate will be back on June 12th and is likely to consider HCR2056, which as amended in the Senate Elections Committee, will hinder early voting, especially for those in rural areas and Tribal communities.

The Arizona House of Representatives will be back on Tuesday, June 4th, and it appears they will be considering at least two godawful bills. The first is [HCR2060 Now: border; benefits; fentanyl; illegal entry](#). It will make it easier for law enforcement to engage in racial profiling and to investigate and detain suspected undocumented individuals. It is very likely unconstitutional, would cost the state a lot, and, of course, is inhumane, seeking to criminalize people for seeking opportunities and reuniting with their families. Call your state representatives and ask them to vote no on HCR2060. [Find your representatives phone numbers here](#).

The second bill the House is likely to consider is [HB2201 water; transportation; turf; land divisions](#). It is a Christmas tree of bad water provisions written by and for developers, land speculators, hedge funds, private water companies, and two places that do not have assured water supplies for development -- Buckeye and Queen Creek. They want the rules changed to get around the groundwater modeling that demonstrates that they do not have enough water and also to create big exemptions to the assured water supply program, so they can keep building the same old sprawl development.

Senate Democrats stayed strong and voted against this bill. We need the House Democrats to do the same.
