Structure and Time Commitment

The Executive Committee is the elected leadership team that governs and supports the Idaho Chapter of the Sierra Club.

- Two-year staggered terms
- Two to four officers: president, vice president, secretary, treasurer
- One member is elected by the board to serve as delegate to the Council of Club Leaders
- Executive Committee meets four times a year, with dates/times decided each year
