# Renew Jacksonville Campaign Update

#### Regional Climate Action Plan Update

Larry Zwain indicated the Northeast Florida Regional Climate Action Plan was submitted to the EPA in March and could be funded for as much as 93 million. Should have feedback by July, which will lead to the comprehensive plan which needs to be submitted in 2025.
