Legislative Session Overview

The 2023-24 Legislative session sadly followed the same old script as the last one: a lack of progress on key issues and troubling attacks on our democracy. Luckily, Governor Evers stepped up to the plate, using his veto power to protect the environment and push through a budget focused on environmental justice. It's important to recognize that the ongoing inaction from the legislature is unacceptable, especially when people are struggling with contaminated water and climate change is causing real damage. We need to act now—there's no time to waste on politics.

We must ensure that Wisconsin's drinking water is safe, protect wildlife from the looming extinction crisis, and take bold steps to mitigate the worst effects of climate change. Unfortunately, the bills introduced last session did the opposite. The bills threatened our water sources, wildlife, and climate stability. Thankfully Governor Evers stood up for our climate, water, and wildlife and vetoed these harmful bills.

The Wisconsin State Senate's votes to deny a number of appointments, including Natural Resources Board members, in the last session was a blatant disregard for democracy and public interest. It was a despicable move that undermined responsible governance and catered to short-term political agendas at the expense of long-term conservation efforts.

Politics over people has become the theme of this recent session.

Sierra Club Wisconsin 2023+24 Legislative Scorecard

Scorecard Overview

Sierra Club's 2023-24 Legislative Scorecard looked at specific votes that the legislators took. We scored 15 votes the Senate took and 8 votes that the Assembly took- they did not vote on appointments and some bills passed on a 'voice vote' and were not scoreable, indicated by *.

The bills we looked at fall into five categories: energy, water, land, wildlife, and democracy.

States and the provide states and



Lands, Water, and Wildlife

While the Department of Natural Resources (DNR) has spent the last two years carefully creating land, water, and wildlife regulations based on science and public input. The Legislature spent the session undermining their ability to do that.

SB 312- PFAS Farce

While SB 312 aimed to address perfluoroalkyl and polyfluoroalkyl substances (PFAS) contamination, it did so by undermining the Dept. of Natural Resources authority and limiting the ability to hold polluters accountable.

Pro-Democracy Position: nay

Status: SB 312 passed both houses and the Governor vetoed the bill.

AB 541 - The Fill Bill

This bill allows our lakes to be built on by developers, even though the lakes are owned by all Wisconsites.

Pro-Democracy Position: nay **Status:** AB5471 passed both houses and was signed into law by the Governor.

SB 139 - Wolf Population Bill

This bill required an arbitrary wolf population goal, rather than having science determine management.

Pro-Wildlife Position: nay

Status: SB 139 passed both houses* and was vetoed by the Governor.

AB 512 - Expanding Hounding

This bill would have expanded hounding (the practice of using dogs to chase down animals while hunting) by allowing hounding in May and June, even though it's a fragile time for wildlife.

Pro-Wildlife Position: nay

Status: AB512 passed both houses* and was vetoed by the Governor.

Democracy

Fundamental rights and constitutional protections, like the separation of state, voting rights, fair electoral maps, and more were under attack this session.

Appointments

We saw a blatant display of partisan politics when the Senate voted to reject nominations for a number of extremely qualified, experienced, thoughtful nominees to the Natural Resources Board and Public Service Commission. This was done to control the decisions these entities take. This is not what the process was set up to do.

The appointment votes we scored include:

- Todd Ambs, Natural Resources Board (NRB 2)
- **Tyler Huebner**, Public Service Commission (PSC 1)
- **Dylan Jennings**, Natural Resources Board (NRB 3)
- Sandra Dee Nass, Natural Resources Board (NRB 4)
- Jim VandenBrook, Natural Resources Board (NRB 5)

Pro-Democracy Position: aye **Status:** These extremely qualified candidates were removed from their positions.

AB 70 - Riot Bill

This bill tried to make 'riots' a felony, but used overly broad language, which could criminalize peaceful protesters who are unaware of any violent acts, potentially suppressing free speech and lawful assembly

Pro-Democracy Position: nay **Status:** AB 70 passed the Assembly but was not voted on in the Senate


AB 415 - Legislative Redistricting

After it was clear that the Wisconsin Supreme Court would not allow Wisconsin's gerrymandered maps to continue, AB415 was proposed as an alternative process; however, it allowed the legislature to maintain too much power.

Pro-Democracy Position: nay

Status: AB415 passed both houses and was vetoed by the Governor.

Climate and Energy

Our dependence on fossil fuels has alarming consequences, so moving beyond coal, oil, and gas to clean energy and transportation is a top priority. Instead of encouraging more clean energy and efforts to curb carbon emissions, the legislature prioritized bills that would restrict the use of clean energy and clean vehicles and appliances.

AJR6-Leg Overreach

This proposed constitutional amendment would give the legislature sole control over how federal funds are allocated, stripping the governor of the ability to distribute those funds without legislative approval. The was created to undermine the usage of the federal clean energy money that resulted from the Inflation Reduction Act.

Clean Energy Position: nay

Status: This passed both houses and was put on the August 13 ballot where it failed.

AB 141 and 142 -Dirty Vehicles and Appliances

These bills were meant to limit the sale or use of motor vehicles (AB142) and appliances (AB141) based on their power source, specifically targeting policies that would potentially limit the use of gaspowered vehicles.

Clean Energy Position: nay

Status: AB 142 passed both houses and was vetoed by the Governor.

SB49- Local Energy Ban

The bill aimed to prevent local governments from restricting energy sources like natural gas, aiming to maintain consumer access to it and prohibit local bans on certain energy services. This bill would have undermined the ability for local governments to continue to lead on climate action.

Clean Energy Position: nay

Status: SB49 passed both houses* and was vetoed by the Governor.

AB 480 - Limiting Solar

This bill would have limited the ability for farmers to receive farmland preservation tax credits if they have solar on their land, hurting our farmers when they need the revenue from solar the most.

Clean Energy Position: nay

Status: AB480 passed both houses and was vetoed by the Governor.


