ACTION ALERT! Let Your County Board Members Know You Support Wind Energy!

Major Anti-Wind Forces Are Threats to Clean Energy Projects We All Need

Peoria and Stark counties could have the many benefits of wind farms for decades ahead, including large annual local tax payments for schools and other services, and clean energy power for tens of thousands of homes. Property owners who wish to lease land for wind farms will gain reliable annual payments to boost their income. Land owners should have freedom to farm wind.

Please phone and email your Peoria or Stark County board members as soon as possible. Let them know that you support wind energy and how essential wind farms are for providing clean and renewable energy, greatly reduced carbon emissions, and annual economic benefits to property owners and local governments.



ADM CO2 Sequestration Deep Injection Monitoring Wells Fail: Your Comments to U.S. EPA and Illinois DNR Needed

Ask for a Ban on Any New CO2 Injection Wells Until Full Information and Solutions Found at ADM

Archer Daniels Midland (ADM) knew in 2022 that they had a carbon dioxide monitoring well problem but they did not inform EPA. The public first learned of this when U.S. EPA issued a violation notice to ADM September 13th, 2024, due to a leaking monitoring well that allowed the movement of injected carbon dioxide and formation fluids containing chemicals, wastewater or other substances, into unauthorized zones deep underground. The company indicated corrosion was the leak cause at the base of the monitoring well where the first leak was detected. Then, in a September 27th letter to EPA, ADM stated the company is stopping all CO2 underground injection due to failures found in their remaining monitoring well.



The second leak is still under investigation, but concerns include this leak may be from a hole in the CO2 storage reservoir meaning the ground layers stated to permanently keep the CO2 deep underground are not perfect. Repeated claims by carbon dioxide sequestration and injection proponents that ground layers will keep the CO2 from moving are now fully in question. Until these incidences, ADM was the nationally leading success story for carbon capture and sequestration.

Please send your personal letter, email, or phone your U.S. Representative and Senators. Ask they support a freeze on all Carbon Dioxide Deep Well Injection permits until ADM has made public why their monitoring wells leaked, how they are preventing the escaped CO2 and formation fluids from migrating further, and how these problems will be prevented in the future. 22 new CO2 injection deep well permits are pending in Illinois. We urgently need a Hold on any new permits and a Ban on any CO2 injection where aquifers are at risk. If you are online, please go to the Prairie Rivers Network webpage or the Protect the Mahomet Aquifer website and sign their petition pages to ban CO2 sequestration under the Mahomet.

to oppose these wind projects and opponents are attending county meetings and sharing their anti-wind views. This is before the companies have even filed applications to the counties.



Community Conversations on Climate: Shaping Policy on Clean Energy

The HOI Group of the Sierra Club joined with the Illinois Clean Jobs Coalition and its partners to promote an ambitious environmental agenda that includes shaping policy on clean energy, clean buildings and clean transportation. This fall, the HOI Sierra Group held two community conversations on climate; in September we held a forum on Clean Energy at the Peoria Universalist Unitarian Church, and in October, a forum on Clean and Safe Buildings at the Carver Center in downtown Peoria.

"Watts Up with Clean Energy" opened with remarks by Reverend Innis, Senator Dave Koehler, and Alisha Granderson, followed by an information-packed presentation from Andrew Rehn, Director of Climate Policy at the Prairie Rivers Network. These were followed by lively questions and discussion. Senator Koehler summarized a forward-looking energy and environmental legislative agenda, Andrew Rehn succinctly laid out what we have accomplished in moving toward a clean and sustainable energy grid and what still needs to be done, and Alisha Granderson delivered an impassioned and poignant argument for environmental justice drawn from personal experience. We had 42 people in attendance and many stayed for discussion afterward.

Our second Community Conversation on Climate was held at the Carver Center in downtown Peoria in October. The main presentation, delivered by Scott Allen, Energy Policy Specialist with the Citizens Utility Board, focused on how to affordably and equitably transition away from fossil fuel appliances in homes and apartments. The continued use of gas appliances indoors can result in dangerous benzene and nitrogen dioxide levels that have been shown to result in increased childhood asthma and other respiratory illnesses. This disproportionately affects black, brown and lower-income neighborhoods with older homes and apartments. Reverend Marvin Hightower, president of the Peoria NAACP and Alisha Granderson, of the HOI Sierra Club, both delivered poignant remarks on the effects of historic environmental injustice on urban communities of color.

We are grateful to the assistance of the Illinois Clean Jobs Coalition and its partners, which include the Citizens Utility Board, the Illinois Chapter of the Sierra Club, the Prairie Rivers Network, Faith in Place, the Illinois Healthy Community Alliance, and the Peoria NAACP. These events, that involved public comment and surveys, are intended, in part, to let policymakers like the Illinois Commerce Commission know that citizens and voters support clean energy initiatives and to counter the disproportionate influence of the fossil fuel industry and their lobbyists.
