Scuppernong Springs Nature Trail Hike Sunday, October 13 ~ 1PM By Outings Co-Leader Al Sommer



This nature area is adjacent to the Scuppernong segment of the Ice Age Trail. We will do a short hike of the trail connecting about ten springs in the vicinity of and contributing to the Scuppernong River.

This 1-1/2 mile trail takes you by the remains of an old marl pit. (Marl is a calcium carbonate material and silt that is formed in aquatic environments and apparently at one time had a value that made it worth mining.) It also takes you to about ten different springs that all have mostly different environments and are fun to see. Who doesn't like to watch water coming out of the ground and moving bits of calcium carbonate and silt around?!?

This nature trail and one of the trailheads for the Scuppernong segment of the Ice Age Trail are both near the intersection of Rte 67 and County Rd ZZ, about 5 miles north of the town of Eagle. I look forward to being able to share these unique and beautiful places with other club members and potential members. Upon completing this little hike we can head to Paradise Springs, which is the one-time site of another spring-based hotel.

We will meet in the parking lot for Scuppernong Springs Trail at 1:00 on Sunday, October 13. Be prepared to sign the Sierra Club Outings Waiver.

Our next discussion will be held on Tuesday, Nov. 12 from 7-8 PM


We will be discussing **Winter Counts** by David Heska Wanbli Weiden

A groundbreaking thriller about a vigilante on a Native American reservation who embarks on a dangerous mission to track down the source of a heroin influx. Virgil Wounded Horse is the local enforcer on the Rosebud Indian Reservation in South Dakota. When justice is denied by the American legal system or the tribal council, Virgil is hired to deliver his own punishment, the kind that's hard to forget. But when heroin makes its way into the reservation and finds Virgil's nephew, his vigilantism suddenly becomes personal.

He enlists the help of his ex-girlfriend and sets out to learn where the drugs are coming from, and how to make them stop. As Virgil starts to link the pieces together, he must face his own demons and reclaim his Native identity. He realizes that being a Native American in the twenty-first century comes at an incredible cost. Winter Counts is a tour-de-force of crime fiction, a bracingly honest look at a long-ignored part of American life, and a twisting, turning story that's as deeply rendered as it is thrilling.

White River Bike Trail Outing Sunday, Nov. 17 ~ 1PM

Please bring your bicycle and join me on a 17-mile ride, partially on the White River Bike Trail.



We will meet at the small parking lot on Spring Valley Road at 1PM. As you go west through Burlington on Rte 36 and you are exiting the town you will see Morman Road going north, you will go past Burlington Garden Center, you will see the new modern looking Burlington Clinic to the west and exit Rte 36 on Spring Valley road going south. As soon as you pass over the 83/36/11 bypass you will see the parking lot on the west of the road.

We will go west on the trail through beautiful downtown Lyons, then through beautiful downtown Springfield and soon after that we will turn north on a not too busy road and then east on a less busy road til we get close to Lyons again and will finish the ride on the trail at the parking lot. Bikers who do not want to ride on the road are welcome to do an. out and back ride entirely on the trail. For those riders the trip will be approximately two miles shorter. We will be riding at a relaxed pace and there will be opportunity for discussion of what we see.

HOMES are now available in Wisconsin!

That is, the "Home Efficiency Rebates" program of the Inflation Reduction Act (IRA) which provides rebates for single and multi-family buildings to make them more energy efficient. This program is for home efficiency improvements, such as insulation and heating/cooling improvements.

Focus on Energy has been selected for implementing the IRA's programs in Wisconsin and detailed information is available on their website: focusonenergy.com/ira-homes

A good place to start is to complete a form on the Focus on Energy IRA page that allows homeowners to enter data related to family size and income to see if they qualify for the program. A basic summary with qualifying information is below.

Modeled Energy Savings	Income Level	Single Family	Multifamily*
20% - 34%	Household with incomes less than 80% AMI	100% of project cost, up to \$5,000	100% of project costs, up to \$5,000 per unit
	Household with incomes between 80% AMI and 150% AMI	50% of project cost, up to \$2,000	50% of project costs, up to \$2,000 per unit, \$200,000 building max
	Household with incomes greater than 150% AMI	50% of project cost, up to \$1,500	50% of project costs, up to \$1,500 per unit, \$200,000 building max

For those who qualify, getting a home energy assessment done is a required step in the overall process in this program. The assessment usually costs about \$500 and tax credits are available to cover this cost for those who qualify.

An IRA registered contractor must perform the assessment. A list of contractors and a search tool by zip code is available on the website. The Home Electrification and Appliance Rebate Program (HEAR) focuses on electrical upgrades and electric appliances. It is not yet active here in Wisconsin but should be available very soon.

Guidance is available on Focus on Energy's website for both the HOMES and the HEAR programs but since it can still be a bit confusing, SEGG is talking to some experts who we hope will offer a presentation for members with tips and insights to take some of the confusion out of the process.

Please watch our newsletter and your email for updates on when we can schedule this meeting and let us know if you have questions or special requests related to making our homes and lives more energy efficient that you would like to see included.

Let's help "POWER WISCONSIN FORWARD!"

We Energies plans to increase our rates by 6.9% in 2025 and 4.8% in 2026. These rates are planned despite these facts:

- We Energies is already the most profitable utility in Wisconsin and has the 5th highest utility profit rates in the country.
- Rate increases over the last decade have been over double the rates of inflation. In fact, the Citizens Utility Board (CUB) estimates the average monthly bill for We Energies residential customers jumped from \$57.59 to \$127.29, equal to a 120% increase since 2005. If increases had been consistent with inflation, bills would be under \$95 per month.
 - Racial disparities related to energy burden (percentage of income required to pay energy bills) for Milwaukeeans is among the highest in the nation.
 - We Energies customers are still paying for the Oak Creek coal plant, the most expensive construction project in the history of the state.
 - We Energies shareholders have received increasing dividends for over ten years.
 - We Energies six top executives were paid a combined \$31.2 Million in 2023.
 - We Energies is proposing to spend \$2.1 Billion on new natural gas facilities, for which they will would then request additional increases in 2027.

As a "regulated monopoly," We Energies is required to get approval from the Public Service Commission (PSC) before they can raise our energy rates. Residents have the opportunity to express our concerns to the PSC, which is responsible for regulating utilities in Wisconsin and ensuring that they provide safe, reliable, and affordable services, before they make a decision about the requested rate increases. **Written comments can also be**submitted from now until October 7, 2024 at: https://apps.psc.wi.gov/ERF/ERF/comment/filecomment.aspx?util=5&case=UR&num=111

Root-Pike Watershed Initiative Network

Protecting Lake Michigan comes in many forms. From the iconic lakeshore trash clean up to the less connected but just as impactful native planting, to the large-scale restoration project, all have a place in the protection of local water quality. Root-Pike

Watershed Initiative Network is a Kenosha-based 501c3 nonprofit organization dedicated to projects and programs that restore, protect, and sustain the watersheds of the Root-Pike basin within southeastern Wisconsin. This summer, their team have been busy progressing projects and hosting events that connect the community with water-quality and habitat improving restoration work. Campbell Woods in Mount Pleasant: Two years ago, Root-Pike WIN was in panic mode. Campbell Woods, a 20- acre old growth forest in Mount Pleasant was up for grabs. This area of the Pike River watershed, deemed "ecologically significant", had an uncertain future. Root-Pike WIN had just become a land trust but lacked the financial means to make the acquisition happen. Now, with the help of many community partners and the Department of Natural Resources, the final acquisition of a seven-acre parcel is complete. On August 30th, Root-Pike WIN closed on the land purchase and is now the property owner of Campbell Woods. This area has a storied and tumultuous

history. Now, the final and most gratifying chapter has been written. The full 20-acre parcel of old growth forest and wetland will now remain protected into perpetuity. The space will serve as inspiration to other landowners to shield valuable natural areas from development. A passive trail system is planned and will be open to the public once the restoration is complete. This seven-acre acquisition would not have been possible without the generous donations from the neighboring community and the Department of Natural Resources. Additionally, the Village of Mount Pleasant and Racine County provided significant support to acquire the first 13 acres. Pollinator Patches: Root-Pike WIN's Pollinator Patch Program is a turf to native prairie conversion program at underserved schools and public spaces. The program creates living classrooms to connect K-12 students with WI native heritage, while improving stormwater infiltration, and increasing native habitat for native pollinators, specifically the federally endangered Rusty Patched Bumble Bee. This year so far, over 350 students and volunteers transformed 5,500 square feet of turf to native prairie at Kenosha Bradford High School, and Racine's Harbor Park, Olympia Brown Elementary School and Goodland Montessori School. Additional patches are being planned at the Rex Plex in Pleasant Prairie, Kirkorian Park in Sturtevant, and the Randall Town Hall in Randall, Wisconsin.

Shagbark Recreational Area in Kenosha: Pike Creek is rated as "impaired" by the Department of Natural Resources and Environmental Protection Agency for poor water quality. This condition is mainly because of excessive stormwater - and the pollutants it picks up as it flows over roof tops, lawns, sidewalks, and roads. The solution: native flowers, grasses and

trees, or "the original green infrastructure". To begin implementing these solutions, Root-Pike WIN and the City of Kenosha are converting the Shagbark Recreational Area's 35 acres of turf grass to wetland and native prairie at the headwaters of the Pike River. The groundbreaking event in June invited the community to get involved in the project by planting a "Pollinator Patch". Over 100 locals attended including Kenosha Mayor Bogdala, Senator Kerkman, multiple Kenosha Alders, and volunteers from Bradford and the community. Attendees planted 112 native plants and then got to take a free plant home. In three years, these plants will be prevalent through the Shagbark area, infiltrating and cleaning stormwater while providing habitat for native pollinators. This project is being funded by the Fund for Lake Michigan, National Fish and Wildlife Foundation, U.S. Fish and Wildlife Service, and Microsoft. Learn more at www.tinyurl.com/shagbarkwi


