What We've Funded:

In 2022, we funded a bench at R. B. Winter State Park, and a bench in honor of Jack D. Miller, longtime Sierra Clubber and outdoors enthusiast, funded by members of the NC PA board privately, has been installed.

In 2022, we also funded a battery box to collect batteries for recycling at the Mondragon Bookstore and the CommUnity Zone in Lewisburg.

Our most successful event, in terms of publicity and reaching a wide audience, was sponsoring Van Wagner, musician, popular high school science teacher and environmental advocate, for his concert in Lewisburg Arts Council's Music in the Park series in Lewisburg. In addition to a lengthy introduction, Van Wagner himself gave a long speech praising the Sierra Club's work in protecting the environment.



Our Group Helps A New Park Get Going

For years, an abandoned 4.5 acre wooded tract in downtown Sunbury was plagued with illegal dumping and drug users. Now, former mayor Kurt Karlovich is making changes. He's turning the city-owned property into a municipal park called S.W.E.E.P. – Sunbury Wetlands Ecological and Educational Park. The project is being funded with grants from various organizations and volunteers perform most of the work. Last year, the North Central PA group donated \$500 to the new park. The park is the site of a federally protected Palustrine Wetland. Volunteers, including Boy Scouts, are in the process of removing invasive plants among other necessary work preparing the location. The Park is between 6th and 8th Streets and Race and Line Streets.

To celebrate the installation of signs that noted the contribution of both our North Central PA Group and the Huplits Foundation, whose grants are overseen by the Allegheny Group of the Sierra Club, we visited Kulpmont at the invitation of Steve Motyka, VP of the Shamokin Creek Restoration Alliance (SCRA), to tour the park SCRA has created on the site of an old colliery and see the storm water retention area or "rain garden" that our money is helping to fund. This small group of volunteers working on restoration of the Shamokin Creek is impressive with their dedication, professionalism, and achievements.

The Shamokin Creek Restoration Alliance has worked tirelessly for the past decade to improve conditions of Veterans Memorial Field, revitalizing it and drawing visitors. On April 25th, the project will be honored at an event hosted by the Pennsylvania Environmental Council.

The Governor's Award for Environmental Excellence chooses twelve projects each year across the state to receive the award. Working to Save the Climate

Jack Miller and Judy Marvin continue to serve on the State Chapter's Food & Ag Conservation Team, and, happily, now we are joined by Kristen Carino. Judy Wicks of All Together Now PA agreed to be our speaker at our webinar on hemp.

165 people have watched this webinar, Localization and Hemp, on YouTube, and if you haven't, take a look! Bio-based materials like hemp can replace PVC and plastics in many industries, including the building sector.

According to Hemp Today, the USDA has \$3.1 billion to support crops that reduce greenhouse gas emissions or sequester carbon, but only \$35 million, or 1%, has been granted for hemp projects.

The Food & Ag Conservation Team also hosted a recent webinar on the prevalence of PFAS chemicals in PA waters and soil, and plans on an upcoming webinar later in the year on personal and environmental benefits of adopting a plant-based diet.

Fighting a Proposed Plastics "Recycling" Plant

One year ago, the residents of the Northumberland/Danville area learned we could be the site of a Chemical Plastic Recycling Plant, Encina. Nearby residents express concerns about the proposed plant because it is a new company, with just one pilot plant in Texas for which we have seen no information. Citizens are concerned about the safety of the plant and the process they plan to use. Plastic from New York City, Philadelphia and other urban centers will be sending 100 trucks a day to the facility. Chemical Recycling has shown very poor results.
