1. <u>Greetings/Introductions</u>

2. Announcements

Lani is involved with campaigns, including for Kristin Brown, and went to Reno to canvas with Swing Left..; Steve led a hike recently at Quail Hollow; Mike said that the Sierra Club failed to show up and support a at a County Supervisor's meeting to speak about the proposal to prohibit sales of filter cigarettes.

3. Changes to the Agenda

4. <u>Minutes of August 2024 Meeting</u>

Steve moves to approve the minutes as amended. Mike seconds. Passes 3-0-1. Lani recuses herself.

5. <u>Treasurer's Report (Steve Bakaley)</u>

Steve gave the Treasurer's report, including balances.

6. <u>State and Chapter Issues.</u>

Mike brought up the chapter and State issues. Steve Bakaley talked about his concerns about the security of the Chapter website. Lani mentioned that John Laird and Jimmy Panetta took positions contrary to the Sierra Club regarding a Salinas bus lane project.
