Subject: Majority of Missouri Voters Favors E.P.A.'s Clean Power Plan

Date: November 11, 2015

A new Public Policy Polling survey finds that a majority of Missouri voters supports the U.S. Environmental Protection Agency's plan to limit the amount of carbon pollution that power plants can release. 56% of Missourians favor the E.P.A.'s Clean Power Plan, while only 37% oppose it. Confidence in the E.P.A.'s direction on the issue is high, with 64% saying they trust the scientists at the E.P.A. more than members of Congress to decide whether there should be limits on air and water pollution. Majorities across a broad range of demographic groups—including women, men, Democrats, Republicans, Independents, young voters, and seniors—are highly receptive to the E.P.A.'s expertise.

Key findings from the survey include:

- The Clean Power Plan is backed by a diverse, broad-based coalition, including majorities of women (61%), men (50%), Democrats (77%), Independents (50%), and seniors (54%).
- 51% of voters say they would be more likely to vote for a candidate for U.S. Senate from Missouri if he/she supported the Clean Power Plan, including 30% who say they would be much more likely to vote for such a candidate.
- By a sizeable 59/34 split, Missourians think that the state should be investing more in clean, renewable energy sources like solar and wind instead of traditional sources like coal, oil, and gas.
- Climate change is an increasingly important issue for Missouri voters. 56% have reached the consensus that climate change is a serious problem, with 35% of those saying that it is a "very serious" problem.

PPP interviewed 683 registered Missouri voters from November 5-8. The margin of error for the poll is +/-3.8%. The poll was sponsored by the Sierra Club.
