SOLAR POWER PROVIDES FREE HOT WATER AND COLD DRINKS DURING POWER OUTAGES

With the increasing occurrence of hurricanes, most Floridians have been spending a long time without electricity, taking cold showers and storing food in ice boxes. Floridians have been asking to bury the electric power lines underground to increase power reliability. Instead, we should eliminate our dependency on the power lines by generating our own power. Traditionally, electricity has been generated only at the power plants, then sold to consumers through the power grid. This concentration of power (pun intended) must end: we should employ distributed solar power generation if we are to reduce our dependency on the power

grid, slow global warming, reduce pollution, and seek sustainable lifestyles. Floridians should be especially concerned about global climate distortion due to our increased vulnerability to hurricanes and rising sea levels.

Fortunately the average family home has enough roof space to power the entire house with solar energy. While you're in the office in the middle of the day, a thermal solar panel on the roof of your home can heat the water and store it in a hot water tank (\$2,500 - \$3,000 installed cost). What can you do with all the electricity generated by solar electric (photovoltaic or PV) panels on your roof when you're not home to consume it? One option is to store that electricity in batteries so that you will have your comforts when the power grid

FEDERAL TAX CREDITS AVAILABLE IN 2006 FOR SOLAR SYSTEMS AND ENERGY CONSERVATION

For the first time in two decades, significant tax credits are available for making homes more energy efficient and for installing alternative energy solar systems.

According to the EPA Energy Star program (<http://www.energystar.gov/index.cfm?c=products.pr_tax_credits#1>), the Energy Policy Act of 2005 gives different levels of credit depending on the type of improvement made, but the amount of homeowner credit for all improvements combined cannot exceed \$500 during the two year period of the tax credit. This tax credit applies to improvements made from January 1, 2006 through December 31, 2007.

Eligible measures are:

- Added insulation to walls, ceilings, or other part of the building envelope
- Replacement windows
- · High-efficiency gas, oil, and propane furnaces and boilers
- High-efficiency central air conditioning units, including air-source and ground-source heat pumps
- High-efficiency fans for heating and cooling systems
- High-efficiency water heaters, including heat pump water heaters

Incentive amounts are:

- Added insulation: 10% of cost up to \$500
- Replacement windows: 10% of cost up to \$200
- Furnaces and boilers: \$150 for qualifying units
- · Central air conditioning units: \$300 for qualifying units
- Fans for heating and cooling systems: \$50 for qualifying units
- Water heaters: \$300 for qualifying units

Other Tax Credits:

In addition, a separate tax credit for solar hot water systems is available. which is not limited to the \$500 cap. Consumers can earn

Broward Sierra Club General Meetings



fails. Another option is to sell that electricity to the power grid, and buy it back when you come home at night, saving the cost and space requirements of large batteries. Many states have a net metering law where you pay only for the net amount of electricity that goes from the power grid into your house, so if you generate as much power as you consume, you will not have to pay the power company for electricity. If you generate more than you consume, the power company must pay you for that energy. This is a needed incentive, as a PV installation can cost \$10,000-\$40,000, depending on how much power you want to generate. With net metering, the reduced monthly electricity bills recover that installation cost sooner. Some states also provide a rebate of \$5 per watt to offset PV equipment costs.

Florida's Energy Policy:

In "the Sunshine State" the only PV consumer incentive is that Florida waives sales tax on the equipment purchase. There is no law requiring net metering by the power utilities. Instead, once you install PV panels on your home, FPL will come to your house and install a separate meter so that they can buy electricity from you at a lower rate than what they charge you for it. So after you spend all that money on PV panels, FPL will sell the electricity you generated back to you (or to your neighbor) for 50% more than what they paid you for it. The Union of Concerned Scientists gave Florida a "D" because it lacks a comprehensive approach to promoting renewable-energy technologies. (Sun Sentinel, December 2005). continued on page 4

VICTORY ON OVERFISHING

We recently reported on a proposed rule change by NOAA Fisheries that would have seriously weakened federal overfishing regulations. These changes would have allowed overfishing to continue on already depleted fish populations while also eliminating a key 10-year rebuilding plan provision for fish populations currently suffering from overfishing. The public was given 90 days to comment on the rollbacks.

You responded in a big way!

The public generated more than 250,000 comments in response to the proposed rule - with the majority of those comments opposing the roll backs to key conservation measures. As a result, NOAA Fisheries announced last month that It has withdrawn the controversial proposal!

In his latest "Bill's Corner," NOAA Fisheries Director Bill Hogarth credits the outpouring of public comments for the agency's recent decision to reconsider the proposed changes to the over-fishing regulations.

Thank you for submitting your comments and congratulations on the victory.

a tax credit of up to 30% of the cost (\$2,000 max lifetime) for installing PV or solar hot-water systems used exclusively for purposes other than heating swimming pools and hot tubs. The system must use solar power to provide at least half of a home's hot water. The water must be used in the dwelling and the system must be certified by the Solar Rating and Certification Corporation (SRCC).

There is also a \$1,000 tax credit to the producer of a new manufactured home achieving 30 percent energy savings for heating and cooling over the 2004 International Energy Conservation Code (IECC) and supplements. At least 1/3 of the savings must come from improvements to the building envelope (everything that separates the interior of a building from the outdoor environment, including the windows, walls, foundation, etc.), or a manufactured home meeting the requirements established by EPA under the ENERGY STAR program.

There are tax credits for buying energy efficient cars. The largest credit applies to the hybrid-drive Toyota Prius: \$3,100 for the first 60,000 cars sold in 2006. As an added incentive, qualifying hybrid cars can drive in the HOV lane on Florida highways once you purchase a \$5 HOV decal from the DMV.

Although power utilities charge us a surcharge to be spent on conservation incentives and education, they have as much motivation to spend that money effectively as Big Tobacco has for running effective anti-smoking campaigns. Studies have found that we get very little in return for this monthly surcharge. This money would be more effective if it were used to fund a **Sustainable Energy Public Benefit Fund.**

Our appetite for energy, combined with the politicians' unsustainable policy of cramming more and more people into Florida, has resulted in FPL raising its electricity rates to fund the construction of more polluting power plants. That money should instead be spent subsidizing distributed solar power generation. Such poor leadership is no surprise: Florida's state legislature represents its true constituency, the election campaign donors; not the voters. Moreover, Florida's Public Service Commission has a reputation for catering to the utilities rather than the Florida citizens it purports to serve.

What you can do:

- Make your home more efficient and benefit from the numerous Federal 2006 tax credits
- 2. Buy Energy Star rated efficient appliances, and replace incandescent light bulbs with compact fluorescent bulbs.
- 3. Add solar panels to your home. They will pay for themselves in reduced electricity bills.
- 4. During this Florida legislative session there should be some energy bills that include a renewable energy component. Call your state representatives and ask them to support:
 - Mandatory net metering
 - State rebates for solar panel installations
 - A Sustainable Energy Public Benefit Fund rather than power utility-controlled education and incentives
