

Sunday, August 17th: In August, instead of our regular Thursday General Meeting, we will be having our annual Broward Sierra Club Picnic on the Beach at the





PIPELINE ON WHEELS

Explosive crude oil is rolling into the middle of America's cities under cover of night. Oil rail shipments have increased 6,000 percent in the last 6 years, which adds up to about 800,000 barrels of oil transported across America per day, according to the National Transportation Safety Board. However, this increase goes without the same regulatory scrutiny as do other hazardous materials. For example, trains carrying chlorine are totally restricted from

travel through the middle of cities. Not so for volatile crude oil. Rail accidents have skyrocketed, spilling oil, starting fires, causing explosions and tragically costing lives. 69% of the tank car fleet are old cars prone to puncturing. These were designed to carry grain, corn syrup and other harmless materials in the 1960's. These trains roll through small towns, under big cities, over bridges and in pristine wilderness areas. More crude oil was spilled in U. S. rail incidents in 2013 than was spilled in nearly four decades.

Increase of rail traffic, unmarked rail cars, inadequate regulation, proximity to peoples' homes and schools, unprepared fire departments, police and first responders, all contribute to big disaster when an incident occurs. Many low-income communities along tracks risk a higher rate of dangerous industrial accidents and are not told what is in the tanks charging through town. Residents are living surrounded by a higher number of pollution sites, and suffer higher numbers of diagnosed cancer, heart disease, asthma and rare auto-immune diseases.
