FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION

The Florida Fish and Wildlife Conservation Commission (FWC) met in St. Petersburg on Nov. 16 and 17. Although I was not able to attend, after looking at the online agenda I was able to stream the meeting, as it was carried by the government TV network. There

was a lot of discussion on the changing Florida Panther Habitat. Due to high waters there is data that indicates the panthers are moving north. A majority of the panthers are now in the privately held lands. The Commission was seeking federal funds that would reimburse these land owners for any stock that is killed by the panthers.

Another topic dear to us in Broward was the status of the burrowing owls that live in high points of Broward. Several speakers requested that their status should be elevated to endangered. No action was taken at this meeting but action will be taken at the meeting on


Feb. 8-9 or April 19-20. I suggest that our members become acquainted with these meetings to monitor the status of our wildlife and take appropriate action. CORAL REEF DESTRUCTION

The Miami Herald recently reported on the coral reef destruction in the Port of Miami, which was predicted by all environmental organizations before the dredging at the Port to provide access to larger ships.





following local storms." Using evidence gathered by the Corps, including photos taken before, during and after, researchers said sediment spread across an area about 14 times bigger than what was allowed under the Corps permit, causing coral to die."

Rachel Silverstein, the Waterkeeper spokesperson (and a Broward Sierra presenter at our general meeting a couple of months ago) was quoted as saying that the resulting severity and massive impact on the reefs had been "dramatically underestimated" by the Army Corps of Engineers, and that "The monitoring and protocols that were supposed to protect this reef during the dredge clearly failed..."

Once again the governmental powers-that-be have let the environmental watchdogs down, not willing to adhere to well founded warnings!
