ENVIRONMENTAL BILLS IN THE FLORIDA HOUSE & SENATE

IMPLEMENTING CONSTITUTIONAL SOLAR AMENDMENT

SB 90 - Sen. Brandes

Will provide statutory exemption from property assessment and from tangible personal property taxes for renewable energy devices like solar panels to implement the Constitutional amendment approved by voters on August 30, 2016

BAN FRACKING

SB 442 - Sen. Young / HB 451 - Rep. M. Miller

Bans all fracking techniques: hydraulic fracturing, acid fracturing, and acid matrix stimulations, but does not prevent routine well cleanout work

SEND LAKE OKEECHOBEE WATER SOUTH AND CUT THE DISCHARGES TO THE EAST AND WEST SB 10 - Sen. Bradley / HB 761 - Rep. Altman

Would provide for a 60,000 acre reservoir south of Lake Okeechobee to clean water from the lake and then send it south through the Everglades where it will help restore the hydrology of the ecosystem, recharge the aquifer South Florida residents and visitors depend on, and reduce the salinity killing the seagrass in Florida Bay while reducing the harmful discharges to the St. Lucie and Caloosahatchee Rivers and their estuaries (including Indian River Lagoon).

PLASTIC BAGS PILOT PROGRAM SB 162 - Sen. Rodriguez / HB 93 - Rep. Richardson

Would allow coastal communities with populations of fewer than 100,000 to ban or regulate the use of disposable plastic bags as a pilot program from 1/1/2018 through 6/30/2020 (2.5 years), to collect data on the program, and to report it to the Department of Environmental Protection

FLORIDA BLACK BEAR HABITAT RESTORATION ACT SB 1304 - Sen. Stewart and Sen. Torres

Would require the Fish and Wildlife Conservation Commission, the Department of Agriculture and Consumer Services, and the Department of Environmental Protection to coordinate certain duties and responsibilities to protect Florida black bears and to preserve their habitat, and would place a moratorium on black bear hunting until 2027.

WATER BILL FIXES (In House and Senate drafting but unnumbered as yet)

Addresses aspects left out of last year's water bill: Chapter No. 2016-1

- · Monitor how much water is being pumped
- If a Consumptive Use Permit is denied, the Water Management District should consider that in an annual review of the Regional Water Supply Plan
- Establish priority funding for water conservation projects
- Reserve water when an Outstanding Florida Springs requires a recovery plan
- Require Department of Agriculture and Consumer Services to assemble fertilizer use data and get it to the Department of Environmental Protection
- Prohibit Concentrated Animal Feeding Operations, new septic tanks, industrial wastewater treatment plants in the Priority Focus Areas of Outstanding Florida Springs
- Require BETTER Best Management Practices when needed

And tell them to vote NO on this one: IMPLEMENTING CONSTITUTIONAL SOLAR AMENDMENT HB 1351 - Rep. Rodrigues

Another anti-solar bill disguised as pro-solar. In addition to prohibiting tax assessors from increasing the taxable value of a home or business because of a solar installation (already covered in SB-90), it would make it difficult to impossible for any company to install rooftop solar by requiring them to file more than 20 financial disclosures relating the their business, calculate a customer's energy savings based on (unknowable) future (not past) energy rates, follow new codes and standards, etc. etc. etc.




Broward Sierra Club's General Meetings - The first Thursday of each month we have committee reports and an educational program on conservation or environmental issues.

APRIL 22, SAT. DAY KAYAKING/CANOEING AT ST. LUCIE INLET PRESERVE STATE PARK near Stuart. This classic Florida barrier island is accessible only by boat, but it is worth the ride. A 3300 foot boardwalk takes visitors across mangrove forests and hammocks of live oaks, cabbage palms, paradise trees, and wild limes to a neatly preserved Atlantic beach. During the summer months, the island is an important nesting area for loggerhead, leatherback, and green turtles. We will paddle across the Intracoastal and then explore the tidal creeks. After we've worked up an appetite, we'll have lunch and go for an ocean swim on a pristine secluded beach. *Donation:* \$3 members, \$5 non-members if you bring your own kayak or canoe. WATER MATTERS - By Ina Oost Topper & Barbara Ruge, Broward Sierra Excom Chair & Vice Chair

Water Matters Day on March 11th at Tree Tops Park was a great success with over 3000 visitors! We were delighted to have so many people stop by our table to learn about the Sierra Club and the water related issues we are concerned about - everything from basic water conservation at home to the recent alarming increase in horrendous water pollution: green slime, red tides, etc.

On March 15th Broward Sierra Club was invited to address a meeting of the Broward League of Women Voters. Although Vice-Chair Barb Ruge took the microphone, she was supported by our team, Conservation Chair Stan Pannaman, Excom Secretary and environmental science teacher Sue Caruso and Sierra Club organizer Diana Umpierre, Geologist and Pres. of International Dark Skies Association. The topic of discussion was Water, Water, Water.

In February the Excom attended a meeting at Port Everglades to give the U.S. Army Corps of Engineers our opinion about their objective to dredge the port for future, larger shipping use. As you may know, the previous Port of Miami dredging project turned into a major disaster for the coral reefs in that area. Fearful of the same thing happening here, a tremendous crowd showed up at this hearing. This included well-known coral reef preservationists, local citizens alarmed at seeing our coral reefs destroyed, and merchants, hoteliers, boat captains and diving instructors who make their living from reef related tourism. Sharing their expertise on the subject were Rachel Silverstein from Miami

Waterkeeper and Dr. Andrew Baker, Associate Professor, University of Miami's Dept. of Marine Biology. Dr. Baker brought massive coral specimens to show the powers-thatbe what's really at stake.

When reefs, which took thousands of years to grow and are a unique feature of our local water environment, are destroyed in a matter of days due to hasty, inexpert dredging, we need to speak up. THIS time we hope that, somehow, the US Army Corps of Engineers heard our insistent demand to get a third, neutral party, i.e. a team consisting of coral reef scientists, involved before any dredging will take place. Only extensive, professional research can prevent a repeat of the horrendous results from the Corps' destructive dredging at the Port of Miami. Conservative estimates project a minimum of 25 years before those reefs recuperate to what they were, barely a year ago.

And it would spare the Corps from, once again, having to sheepishly admit a few months later that "our research data were totally inadequate, and severely outdated."

If and when the opportunity to have your voice heard presents itself, by all means, please speak up.
