Solar power towers pose extraordinary threat.

here is a giant experiment being conducted in the California desert where scores of super-sized renewable energy projects on the order of 5 to 20 square miles per project, are being proposed mostly on pristine federal desert

lands. No one with any biological background can deny the extensive landscape-level threats these pose.

Not so well known is one aspect of this experiment that has the potential to become the Frankenstein of renewable energy: namely, giant solar thermal "power towers." These contraptions are not photovoltaic solar panels (PV). Unlike PV, these power towers are hundreds of feet high, involve thousands of

tracking mirrors, are very expensive to build and operate, and basically superheat fluids to 1000 degrees Farenheit to run a conventional generator. Also unlike PV, this process consumes significant amounts of natural gas and water to

Power towers have an especially scary side. With their incredibly bright glow, they are thought to function as "mega traps" for birds. Their bright light lures millions of insects and thus their bird predators towards the huge cone of heat surrounding the towers, where the birds

City of Riverside Special Municipal Election

rom the visitors' center on the bluffs overlooking the Santa Ana River's 1,100-acre Hidden Valley Wildlife Refuge you can see all the way across western Riverside and San Bernardino counties to the towering ramparts of the San Gabriel and San Bernardino mountains. Just behind the center and tucked away in the western corner of the City of Riverside are still 650 open acres. This is the last undeveloped part of the historic Hole Ranch, which was farmed to grow flowers.

Combined, these unspoiled lands and river form one of the most impressive open natural areas in Southern California. "Hidden," yet accessible and close to the growing populations all around, this special area offers a full dose of what an urban-weary resident badly needs: tranquility, majestic views and exhilarating walks. This grand setting beside the river is also the right spot to introduce kids to nature.

Now these invaluable assets are threatened and we need your help to save them.

Measure L, on the

City of Riverside's November 4th ballot, would repeal voterapproved initiative laws protecting the La Sierra area and allow a 1,950-unit

housing project next to the river refuge. That's twelve times the 162 homes allowed now.

Measure L exempts the developer from environmental mitigation and good planning. The housing project generates 20,000 more daily car trips. No unified plan or funding is required for public facilities like schools, parks, police or fire stations that such a large development needs. The project can be divided, sold and built piecemeal. A new residential zone created by Measure L for the project, which could be applied throughout the city, has no limits on building heights, number of stories or set-backs from neighbors. High-rise apartments could be built!

All of Measure L's \$700,000+ campaign funding comes from one Nevada company, "New West Riverside LLC," which is run by a Las Vegas

GENERAL INFORMATION, RULES & DISCLAIMERS

All Outings Leaders are Chapter Certified Leaders having appropriate Outings Training Courses, First Aid Courses, & experience for the Outings they lead. **LEADERS** may exclude individuals from participation if they believe they may not be qualified. Non-Sierra Club members may join outings unless otherwise stated in the write-up. All participants agree to abide by the Leader's rules. Participants should **CALL THE LEADER AHEAD TO SIGN-UP**.

WHAT TO BRING

Many Outings specify items to be carried by EACH participant. Do not attend Outings without the specified items unless you have first discussed it with the leader. Often the TEN ESSENTIALS are required. They are: 1) map, 2) compass, 3), flashlight, 4) knife, 5) windproof/waterproof matches in waterproof case, 6) fire starter, 7) first aid kit, 8) extra food & water for emergency use only, 9) extra clothing including rainwear, & 10) sun protection including sunscreen/sunglasses/hat.

ADVENTURE PASS SPECIAL NOTICE

Most outings occurring in the San Bernardino, Angeles, Cleveland, or Los Padres National Forests require a Forest Service permit for each vehicle (Adventure Pass). They are indicated by ** in the calendar. Be sure to contact the leader regarding permits. The permits cost \$30 per year or \$5 per day; however they may not be obtainable the day of your Outing. If you arrive at the meeting place without making arrangements with the leader & you don't have a permit or find a ride in a vehicle with a permit, you will not be able to attend the outing. You are expected to share the cost of the daily permits equally among everyone in the vehicle or a suggested \$.50 contribution from everyone for annual permits (above normal mileage contribution). America the Beautiful Interagency Passes may be used in lieu of Adventure Pass.

CARPOOLING POLICY

In the interests of facilitating the logistics of some outings, it is customary that participants make carpooling arrangements. The Sierra Club does not have insurance for carpooling arrangements & assumes no liability for them. Carpooling, ride sharing, or anything similar is strictly a private arrangement among the participants. Participants assume the risks associated with this travel. Drivers should have adequate insurance coverage & their vehicles should have no safety defects. Drivers of carpools agree to not consume any alcoholic beverages. It is customary for riders to share expenses with the driver. Five cents per mile per person for short trips is suggested while three cents per mile per person over 100 miles is usually reasonable.

LIABILITY WAIVER

In order to participate on one of the Sierra Club's outings, you will need to sign the following liability waiver:

Sign-In Sheet & Acknowledgment of Outing Member Responsibility, Express Assumption of Risk, & Release of Liability

I understand that during my participation in this Sierra Club Outing, I may be exposed to a variety of hazards & risks, foreseen or unforeseen, which are inherent in each Outing & cannot be eliminated without destroying the unique character of the Outing. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, & death ("Injuries & Damages") from exposure to the hazards of travel & the Sierra Club has not tried to contradict or minimize my understanding of these risks. I know that Injuries & Damages can occur by natural causes or activities of other persons, animals, trip members, trip leaders & assistants or third parties, either as a result of negligence or because of other reasons. I understand that risks of such Injuries & Damages are involved in adventure travel such as Sierra Club Outings & I appreciate that I may have to exercise extra care for my own person & for others around me in the face of such hazards. I further understand that on this Outing there may not be rescue or medical facilities or expertise necessary to deal with the Injuries & Damages to which I may be exposed.

In consideration for my acceptance as a participant on this Outing, & the services & amenities to be provided by the Sierra Club in connection with the Outing, I confirm my understanding that:

I have read any rules & conditions applicable to the Outing made available to me; I will pay any costs & fees for the Outing; & I acknowledge my participation is at the discretion of the leader.

The Outing begins & ends at the location where the Outing officially commences with leader & participants in attendance, as designated by the Sierra Club ("Trailhead"). The Outing does not include carpooling, transportation, or transit to & from the Trailhead, & I am personally responsible for all risks associated with this travel. This does not apply to transportation provided by the Sierra Club after the commencement & before the end of the Outing.

If I decide to leave early & not to complete the Outing as planned, I assume all risks inherent in my decision to leave & waive all liability against the Sierra Club arising from that decision. Likewise, if the leader has concluded the Outing, & I decide to go forward without the leader, I assume all risks inherent in my decision to go forward & waive all liability against the Sierra Club arising from that decision.

This Agreement is intended to be as broad & inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby & shall remain valid & fully enforceable.

To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, & RELEASE FROM LIABILITY, & to INDEMNIFY & HOLD HARMLESS the Sierra Club, its officers, directors, employees, agents, & leaders from any & all liability on account of, or in any way resulting from Injuries & Damages, even if caused by negligence of the Sierra Club its officers, directors, employees, agents, & leaders, in any way connected with this Outing. I understand & intend that this assumption of risk & release is binding upon my heirs, executors, administrators & assigns, & includes any minors accompanying me on the Outing.

CONSERVATION

Ed Wallace represented the group at a meeting with the consultants and City of Big Bear Lake on a bike and hiking path being planned along Rathbun Creek from the Big Bear Lake to Sand Canyon just east of Bear Mountain ski resort. As a part of this project the creek will become more meandering in nature and some of the original wetland will be restored. It is hoped that this path, which parallels Moonridge Blvd., will also help to revitalize the business district along this corridor.

The Big Bear Group continues to participate in the Sawmill Pebble Plain preservation project. Since the San Bernardino Mountains Land Trust has acquired the High Timber Ranch Property that borders the Pebble Plain, 15 truckloads of trash have been removed from the property including 44 truck and auto tires, a spa, a fireplace insert, and uncounted numbers of couches, chairs, mattresses and televisions. As this cleanup effort has progressed, many access roads that facilitated trash dumping, illegal wood cutting and degradation of the Sawmill and Villa Grove Pebble Plains have been closed and

OUTINGS – A Visit to Ansel Adams Wilderness, by Ed Caliendo, Outings Chair In late August, a group of seven experienced backpackers visited the Ansel Adams Wilderness located in Northern California, approximately 500+ miles from Los Angeles and our home in the San Bernardino Mountains. The planned trip allowed for two full days of driving to reach and return from the remote wilderness area. The Ansel Adams Wilderness, named after the famous photographer after his death in 1984 is located north of Fresno and Oakhurst, California, off of Hwy 41 and within the Inyo National Park.

The entire Ansel Adams Wilderness spans 231,533 acres. Our visit consisted of visiting only a small 12-mile Lillian Lake Loop. Because of the distance in driving, as well as elevation change to 8810', we spent our first night at the nearby Bowler Group Campground. The next day we began our trek for the Fernandez trail (7512') and backpacked 6.4 miles to our future base camp at Staniford Lakes (8810'). See photo below. We camped adjacent

to large glaciersmoothed rock
slabs above

On our way to our base camp at Staniford Lakes, we stopped at





Vandeburg Lake (8650'). From our base camp we day-hiked to six other nearby lakes: Lady Lake (8908'), Chittenden Lake (9182'), Lillian Lake (8868'), Flat Lake (8920'), Anne Lake (9503') and Rainbow Lake (9258').

One of our stranger experiences was dealing with isolation. We saw no other

people or contact with the outside world during our five-day stay in the Ansel Adams Wilderness; however, we did see deer and other smaller creatures, but no bears. We saw other backpackers only upon entering and exiting the Wilderness. Five days without contact with the busy world! What a wonderful experience!

The proposed 41,600,000 square foot warehouse project would put 41,600,000 square feet of warehouses on 2,710 acres of land south of Highway 60. If built, it would share a two-mile border with the San Jacinto Wildlife Area, home to threatened/endangered species as well as more than 20 species of raptors. The final environmental documents may be released sometime in November for all to review. Please plan on attending planning commission and city council public hearings on the WLC. You can speak or attend and to support those who speak. It is important that all voices be heard in the planning process. Please contact planner Mark Gross at: markg@moval.org & (951) 413-3215 for more information & to be notified of all meetings.

Donations are needed to help us as we work to provide strong comments on the World Logistic Center project. 

Santa Margarita Group By Teri Biancardi

he Santa Margarita group kicked off its first meeting after the summer break with a presentation on a topic no Southern Californian can ignore — the drought. There was not a lot of comfort in what our Rancho Water representative had to say, but it's clear that this third year of drought is focussing minds and changing behavior. People have been ripping out their lawns in droves, maybe in response to high water bills, or because of the turf rebates, or both, but Rich Williamson told the audience the message of conservation is getting through, none too soon, as the prospect of a wet El Niño year fades.

We're continuing the theme of water with a presentation on climate-friendly landscaping for October, and in general, we're very excited about the speakers and subjects we have planned for the next eight months.

Our monthly meetings are only a small part of what the Santa Margarita Group gets up to, however. In September, Gary Marsalone led an early morning 9-miler in Idyllwild, while our newest hike leader Margaret Meyncke led a fun and gentle two-and-a-bit mile hike on the San Juan Loop trail which even managed to fit in a trip to a candy store! She's also leading a three-miler on October 11th on the Agua Caliente Trail in Warner Springs which is a section of the PCT. Margaret's hikes are aimed at people who want to get out and experience nature, but may not be quite as ambitious in their distance or elevation changes than some of the more sturdy of us. And they dovetail with our Outdoor Families program.

We've also got a bike ride to Oceanside and back on the San Luis Rey River trail on October 19th, and not to be outdone, our Activities Director Laurie Webster has organized a spooktacular event for that same evening, an Old Town Temecula Candlelight Walking/Ghost Tour, at 6:30 pm. Then on the 25th we have a challenging hike along the Fuller Ridge Trail in Idyllwild again. Finally, Bob Audiberg is leading a 7-miler at Cedar Springs on Nov. 15th.

Specific to Outdoor Families, our environmental education meet-up for homeschooled students, we've had a well-attended apple picking excursion in Sunshine Summit and later in October we'll visit Pelzer Farm in Temecula wine country, followed by a docent-led Santa Margarita River hike. Back in the city, the SMG has been asked by local middle and high school teachers to help with their environmental units. are burned alive in flight or, alternatively, have their feathers melted, resulting in a lingering death.

There are three of these power towers at the controversial Ivanpah Solar project in San Bernardino County, developed by a company called BrightSource. The towers are immense: each 450' high, surrounded by tens of thousands of mirrors on 6 square miles. Workers at Ivanpah callously call the flaming birds "streamers." Federal investigators mounted a sting operation where they observed these incineration events very few minutes. Expert testimony before the California Energy Commission (CEC) estimated that the mortality caused by a fully functioning Ivanpah power tower could be 28,000 birds a year.

But in addition to its extreme environmental impacts, the evidence shows that the Ivanpah power towers are having significant technical problems. According to the California Independent System Operator daily reports, Ivanpah has been plagued with outages since it came online in January. During the month of September for instance, there wasn't a single day that all three Ivanpah units were generating at rated capacity. On 21 days of the month, one or more units reported as completely offline. And for 6 of those days, all three units were out! This project got some of the biggest federal stimulus monies of all, so one has to wonder: will Ivanpah prove to be the next Solyndra?

Palen SEGS is Ivanpah on steroids

Not withstanding Ivanpah's unsettling track record, its developer BrightSource recently applied to CEC for a permit to build more power towers—this time on the southern flank of Joshua Tree National Park, and within the Pacific Flyway for migratory birds on their epic journey between the southern and northern hemisphere each year. The project was named Palen SEGS, and this time the towers were to be twice as tall as Ivanpah—an astounding 750' high each, and potentially twice as deadly to birds according to CEC staff.

The troops rallied when the CEC initiated its review of the Palen power towers. Joshua Tree National Park wrote a letter enumerating the project's impacts to resident Golden Eagles and other protected species, as well as the fact that the painfully bright light from the towers would be visible from a vast proportion of the Park's pristine wilderness areas. The Colorado River Indian Tribes hired the top law firm of Shute Milhaly to defend against the landscape-level damage this project would inflict on their cultural heritage. The Center for Biological Diversity countered the developer's specious claims that the technology would be biologically benign. Stalwarts, Basin and Range Watch and La Cuna de Azatlan intervened. Sierra Club and National Parks Conservation Association also petitioned to intervene against the project, but were

Mysterious withdrawal of application

Then, in a surprise move late last month, after receiving a potential green light from CEC, BrightSource summarily withdrew its application for Palen! What was that all about?

Did Palen fall of its own weight? BrightSource claimed the reason was uncertainty that the 30% investment tax credit would be renewed at the end of 2016 — but didn't they know that all along? Did the withdrawal have more to do with all those outages that have continued to plague its Ivanpah project? Did united environmental and Native American opposition tip the scales?

We may never know what brought Palen down, but one thing is for sure: there has to be a less destructive way to ramp up solar energy than these Rube-Goldberg power tower contraptions creating huge cones of heat just to run a conventional generator. Three cheers for Sierra Club's new "My Generation" campaign to ramp up rooftop solar PV. Local renewables and energy efficiency are the optimal way to protect the environment and also put jobs where they belong—in our communities!

certainly lead to more efforts to pave over other irreplaceable open spaces and agricultural areas unique to Riverside, damaging the quality of life.

Measure L claims to "save" the hills bordering Norco. But the hills' scenic value is amply protected now by existing low density zoning, home clustering incentives and city grading standards.

Riverside residents, with Sierra Club support, voted three times to protect these lands. First Prop. R in 1979 established zoning for the river area at one house per five acres. Then Measure C in 1987 maximized open space by grouping the homes allowed by Prop. R away from the hills and river. Developers tried to repeal the laws with Measure E in 1989. But Riverside voters again upheld R & C, rejecting E by 77 percent.

We urge Chapter members living in Riverside to urge all their family, friends and neighbors to Vote No on Measure L on November 4th. All Chapter members need to urge family and friends who live in Riverside to Vote No on Measure L.

The team on the Murrieta Creek Trail project is announcing a logo contest, based on the concept of "connections" with the river connecting the four cities and its residents to nature. It will be offered to art and design students in the region and carries a \$500 prize for the winner.

And after the sheep, come the owls. SMG's Meadowview project is utilizing the skills of local woodworkers to build 50 artificial homes for burrowing owls that used to populate the 370 acres of common area in the heart of Temecula, but who largely disappeared after the HOA began disking the land as fire abatement. This year, they used sheep to comply with city fire regulations and eat the native grasses that the owls don't like obscuring their view. In November, the burrows go into the ground and we hope the owls will find their new accommodations luxurious.

SAVING CHINO CANYON


hino Canyon is the last undeveloped alluvial fan in the urbanized areas of the Coachella Valley. Located at the northern entrance to Palm Springs west of Highway 111 and easily viewed from the iconic Palm Springs Visitor Center and Tramway Road. It is the perfect backdrop to the increasingly popular and rapidly developing city.

The Canyon was first inhabited by the Agua Caliente Band of Cahuilla Indians and it is named after Pedro Chino, a powerful shaman who made his home there.

Developers have always eyed the canyon, first it was for water for a growing Palm Springs and a road was constructed to facilitate the extraction process. This was relatively minor and

caused little immediate change. The next major challenge was the construction of The Palm Springs Aerial Tramway which was highly controversial and was strongly opposed by environmental groups, but to no avail and the tram opened in 1963. Around this time, Riverside County Flood Control built a levee that further fragmented the Canyon. It would be more than 25 years until the next serious threat.

In 1989 another developer, Mark Bragg, envisioned "Shadowrock," a major golf/hotel/housing project and purchased 960 acres in the heart of the Canyon, along with a smaller parcel along Highway 111. After discussions with the city, a Development Agreement was announced that would allow this project to be built on both sides of Tramway



When the Agreement started to move forward, the (then) California Department of Fish and Game filed suit against the project on the premise that it would harm or cause the death of Peninsular bighorn sheep in the area. Ultimately, the suit was unsuccessful and the development agreement was extended until 2006. In 1997 the Tahquitz Group with Chapter support filed suit against the project extension and after a long drawn out battle in the courts the suit and subsequent appeal, it was not successful and the developer continued to refine his plans.

In 2004 a group of citizens concerned about Shadowrock and other major hillside developments formed Save Our Mountains, this group was dedicated to limiting growth in the hills and mountains surrounding Palm Springs. The tactics used were the election process and initiatives and referendums were placed on the ballot in 2005. This was partially successful and another development in south Palm Springs was rejected by the voters. The second measure which would have prohibited all large hillside developments, including Shadowrock,

failed by a narrow margin. Also in 2004 another organization was formed by a group of citizens "Friends of Palm Springs Mountains" which was also dedicated protecting local hillsides and mountains. This group would eventually become key players in the Chino Canyon battle.

In 2006, the City Planning Commission voted 5-0 rejecting any extension as it was not in compliance with the current zoning ordinance. The City Council then voted 3-1 and approved another 10 year extension. This resulted in a further lawsuit by the Tahquitz Group and the Center for biological Diversity particularly regarding bighorn sheep issues. Also at this time Save Our Mountains was planning for the next election and with more than enough signatures gathered for a measure to be placed on the ballot to overturn the council decision. In the following election in 1997,

the voters with a 60-40 margin rejected the city council decision and also voted for major changes in the city council.

At this time a private investment company acquired the Shadowrock properties and again threatened to start the development process, though they eventually realized that this would be extremely difficult. Friends of Palm Springs Mountains then stepped in and hired Pete Dangermond, a former director of California State Parks and a very experienced facilitator in purchasing lands for conservation, having worked on preserving the Indian Canyons in Palm Springs and similar work for the Riverside

Lands Conservancy among many others. Pete saw this not just as Shadowrock, but in the big picture as Chino Canyon as a whole and began negotiations with many landowners in the area. At the same time, he was consulting with Federal and State wildlife agencies and the Coachella Valley Mountains Conservancy to bring together funding sources if land was available from willing sellers.

The first success was the purchase of 210 acres along Highway 111 which included Angel Cove and Shiprock which was scheduled for a major residential development. The Friends, pleased with this success, continued negotiations with the investment company (via Pete Dangermond and his assistant, Karin Winters) and eventually after much wrangling over price, legal issues and terms of sale, the Shadowrock properties were finally purchased and the sale recently closed. Along with City-owned conservation lands, more than 75% of Chino Canyon is now preserved. Further acquisitions are being negotiated.

In conclusion, preserving Chino Canyon is an exercise in persistence, tenacity and determination, with strong support of the residents of Palm Springs and judicious use of the legal and political systems.

People's Climate March Draws Over 400,000

At the Sierra Club stage at 75th St., Club president David Scott, Beyond Coal director Mary Anne Hitt, national program director Sarah Hodgdon, former president Allison Chin, and Congressman Keith Ellison of Minnesota were among the speakers, and members of the Sierra Student Coalition fired up the crowd with call-and-response cheers like, "What do we want?" "Clean energy!" "When do we want it?" "Now!"

"We're not going to tolerate lies and obstruction! We're not going to sit back and let a climate catastrophe happen!"

So said Sierra Club president David Scott, above, at a Sierra Club rally on Central Park West just before the start of the People's Climate March in New York City.

"Social justice demands action," Scott said as the crowd pressed in. "For people in low-lying nations, for indigenous people in the Arctic, and for many others, climate catastrophe isn't some far-off threat. It has already started."

"We have solutions," he said to cheers and applause as the crowd swelled in numbers and energy. "What we need now is the political will."

"What do we want?" Scott shouted.

"Climate justice!" the crowd roared back.

"When do we want it?"

"Now!"

Scott then turned the stage over to fellow emcees Karissa Gerhke and BoRa Kim of the Sierra Student Coalition, who introduced several more speakers, including former president Allison Chin. Ten of the fifteen members of the Club's Board of Directors -vice-president Spencer Black, Loren Blackford, Lane Boldman, Michael Dorsey, Jim Dougherty, Chuck Frank, Jessica Helm, Robin Mann, Susana Reyes, and Scott — participated in the march.

But the Board set the stage for the Sierra Club's deep involvement with the event months beforehand. "Back in May, we voted to postpone both our annual meeting and our September meeting, both of which would have conflicted with the People's Climate March," says Spencer Black. "This sent a strong message to Club members of the importance of the march."

Board members played an active role in publicizing and promoting the march in their states, both internally and with partner groups, and several members contributed financially to help with transportation costs. Typical was Board member Chuck Frank, who helped sponsor several Club members to attend the march and rode the overnight bus from Chicago to New York.

"As a Board we supported the Club's deep involvement with what was a very significant strategic opportunity," says Robin Mann. "Our goal from the start was to have a major mobilization right before the UN Climate Summit and partner with a broad diversity of civic organizations to make the march reflect our values of inclusiveness and commitment to climate justice."

Mann's involvement leading up to the march was also typical of Board members: She recruited an environmental justice organization with which her local group was partnering, she helped captain a bus to New York City, and she was deeply involved in local and chapter recruitment efforts in the weeks leading up to the march.

And the work and commitment paid off, as more than 25,000 Sierra Club members participated in the march — the largest-ever Sierra Club gathering. Meanwhile, Sierra Club volunteers and staff helped organize hundreds of solidarity events around the country the same weekend as the big New York march.

"I think we made an emphatic statement to global leaders and the world," says Scott. "And we were involved from the get-go."
