New Desert Monuments in Chapter!

Feinstein Asks for Presidential Designation of Mojave Trails, Sand to Snow and Castle Mountains as National Monuments


s you may have heard, there is something really "monumental" happening in Chapter, and you can help! Diane Feinstein has long championed desert protection, but her recent proposed legislation (California Desert Conservation & Recreation Act) has been wallowing in a regressive Congress. As a result, Senator

Feinstein recently asked President Obama to take action to designate three new National Monuments in the California desert, all of them within San Gorgonio Chapter! Starting with Teddy Roosevelt, Presidents on both sides of the aisle have used the Antiquities Act to protect important and imperiled special places, assuring they will be intact and accessible to the public for this and all future generations. The desert areas for which Senator Feinstein has requested monument designation most certainly merit such protection.

Truly Remarkable Desert Lands

"Mojave Trails" National
Monument would encompass
a million acres of iconic desert

in the central Mojave, forming the vital connective tissue between Joshua Tree National Park and Mojave National Preserve. About half of this land had been given to Santa Fe Railroad in the 1800s, creating a checkerboard of private holdings that was eventually put up for development during the 1990s. So in order to acquire this magnificent landscape, tens of millions of dollars

in private donations were raised and supplemented with federal Land & Water Conservation Funds procured with Senator Feinstein's help. The newly acquired lands were then given to BLM to manage as conservation lands, but subsequently BLM turned around and accepted applications to build mega solar and wind farms on the very land that was acquired expressly for preservation.

If built, these massive man-made installations would have precluded all public use and enjoyment.

Senator Feinstein swiftly stepped in to propose National Monument status for this imperiled area to protect its rich and irreplaceable biological, scenic, cultural and historic resources, including many sacred Native American trails and the most intact stretch of historic Route 66—made famous in Steinbeck's "The Grapes of Wrath." The time has finally come for this iconic land to get the recognition and protection from industrialization that it richly deserves.

"Sand to Snow" is an appropriate moniker for the second National Monument proposal. This new national monument would extend from the hot sands of the San Gorgonio Pass all the way up to the peak of the mountain itself at 11,380 feet, embracing an area of amazing diversity. Within Sand to Snow lie two year-round desert streams, the greatest

the Santa Ana River and much more. This is truly a biological treasure house, as well as a prime recreational resource for many thousands of residents and visitors to California.

Finally, the Castle Mountains National Monument would, in essence, help make Mojave National Preserve whole again. If you look at a map of the Preserve, you'll see a notch in the boundary of the Preserve near the Nevada border; that is the Castle Mountains exclusion. Protection for the Castle Mountains is overdue.

"Paddle Along" With Brian Elliott and Friends as They Canoe Two Rivers in Alaska at Chapter Meeting on Tuesday, November 3rd



Our speaker at the November 3 chapter meeting is Brian Elliot. Brian's presentation is titled Caribou,


Brian and his friends canoed for ten days in 2014 on the Kokolik River. They returned this past summer to canoe nine days on the Utukok River, just east of the

Kokolik River. He and his friends were then air shuttled back to the Kokolik where they canoed for 15 days, this time all the way to the Kokolik's River's mouth at the small Inuit village of Pt. Lay, a subsistence village of 190 people at the

Chukchi Sea's coast.

The rivers flow through some of the most remote wilderness in North America and are renowned for viewing of the western Arctic caribou herd migration. Brian and his friends saw thousands of caribou along with much other

wildlife. Each river is primarily located within the National Petroleum Reserve-Alaska, an area of national interest by the Sierra Club and and other environmental groups who are trying to preserve its great wilderness and wildlife. Brian will share his photos of his trip and advocate for the region's protection.

GENERAL INFORMATION, RULES & DISCLAIMERS All Outings Leaders are Chapter Certified Leaders having appropriate Outings Training Courses,

First Aid Courses, & experience for the Outings they lead. LEADERS may exclude individuals from participation if they believe they may not be qualified. Non-Sierra Club members may join outings unless otherwise stated in the write-up. All participants agree to abide by the Leader's rules. Participants should CALL THE LEADER AHEAD TO SIGN-UP.

WHAT TO BRING

Many Outings specify items to be carried by EACH participant. Do not attend Outings without the specified items unless you have first discussed it with the leader. Often the TEN ESSENTIALS are required. They are: 1) map, 2) compass, 3), flashlight, 4) knife, 5) windproof/waterproof matches in waterproof case, 6) fire starter, 7) first aid kit, 8) extra food & water for emergency use only, 9) extra clothing including rainwear, & 10) sun protection including sunscreen/sunglasses/hat.

ADVENTURE PASS SPECIAL NOTICE

Most outings occurring in the San Bernardino, Angeles, Cleveland, or Los Padres National Forests require a Forest Service permit for each vehicle (Adventure Pass). They are indicated by ** in the calendar. Be sure to contact the leader regarding permits. The permits cost \$30 per year or \$5 per day; however they may not be obtainable the day of your Outing. If you arrive at the meeting place without making arrangements with the leader & you don't have a permit or find a ride in a vehicle with a permit, you will not be able to attend the outing. You are expected to share the cost of the daily permits equally among everyone in the vehicle or a suggested \$.50 contribution from everyone for annual permits (above normal mileage contribution). America the Beautiful Interagency Passes may be used in lieu of Adventure Pass.

CARPOOLING POLICY

In the interests of facilitating the logistics of some outings, it is customary that participants make carpooling arrangements. The Sierra Club does not have insurance for carpooling arrangements & assumes no liability for them. Carpooling, ride sharing, or anything similar is strictly a private arrangement among the participants. Participants assume the risks associated with this travel. Drivers should have adequate insurance coverage & their vehicles should have no safety defects. Drivers of carpools agree to not consume any alcoholic beverages. It is customary for riders to share expenses with the driver. Five cents per mile per person for short trips is suggested while three cents per mile per person over 100 miles is usually reasonable.

LIABILITY WAIVER

In order to participate on one of the Sierra Club's outings, you will need to sign the following liability waiver:

Sign-In Sheet & Acknowledgment of Outing Member Responsibility,

Express Assumption of Risk, & Release of Liability

I understand that during my participation in this Sierra Club Outing, I may be exposed to a variety of hazards & risks, foreseen or unforeseen, which are inherent in each Outing & cannot be eliminated without destroying the unique character of the Outing. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, & death ("Injuries & Damages") from exposure to the hazards of travel & the Sierra Club has not tried to contradict or minimize my understanding of these risks. I know that Injuries & Damages can occur by natural causes or activities of other persons, animals, trip members, trip leaders & assistants or third parties, either as a result of negligence or because of other reasons. I understand that risks of such Injuries & Damages are involved in adventure travel such as Sierra Club Outings & I appreciate that I may have to exercise extra care for my own person & for others around me in the face of such hazards. I further understand that on this Outing there may not be rescue or medical facilities or expertise necessary to deal with the Injuries & Damages to which I may be exposed.

In consideration for my acceptance as a participant on this Outing, & the services & amenities to be provided by the Sierra Club in connection with the Outing, I confirm my understanding that:

I have read any rules & conditions applicable to the Outing made available to me; I will pay any costs & fees for the Outing; & I acknowledge my participation is at the discretion of the leader.

The Outing begins & ends at the location where the Outing officially commences with leader & participants in attendance, as designated by the Sierra Club ("Trailhead"). The Outing does not include carpooling, transportation, or transit to & from the Trailhead, & I am personally responsible for all risks associated with this travel. This does not apply to transportation provided by the Sierra Club after the commencement & before the end of the Outing.

If I decide to leave early & not to complete the Outing as planned, I assume all risks inherent in my decision to leave & waive all liability against the Sierra Club arising from that decision. Likewise, if the leader has concluded the Outing, & I decide to go forward without the leader, I assume all risks inherent in my decision to go forward & waive all liability against the Sierra Club arising from that decision.

This Agreement is intended to be as broad & inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby & shall remain valid & fully enforceable.

To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, & RELEASE FROM LIABILITY, & to INDEMNIFY & HOLD HARMLESS the Sierra Club, its officers, directors, employees, agents, & leaders from any & all liability on account of, or in any way resulting from Injuries & Damages, even if caused by negligence of the Sierra Club its officers, directors, employees, agents, & leaders, in any way connected with this Outing. I understand & intend that this assumption of risk & release is binding upon my heirs, executors, administrators & assigns, & includes any minors accompanying me on the Outing.

I have read this document in its entirety & I freely & voluntarily assume all risks of such Injuries & Damages & notwithstanding such risks, I agree to participate in the Outing. Note: If the participant is a minor, the minor's guardian must sign on the minor's behalf.



2015 CONSERVATION IN REVIEW By: Ed Wallace, Conservation Chair

ots of good things happened in the Big Bear conservation arena in 2015. The Big Bear Group participated in the development of a master plan for the Rathbun Creek Corridor project.

This project when completed will culminate in a multi-use trail from the National Forest in Sand Canyon to the Lake. It will also result in improved riparian habitats along the creek

The Group was active in the continued development of the Pebble Plains Wildlands Park which is situated between Moonridge and Sugarloaf. When completed, this park will help conserve one of the last pristine pebble plains in the Big Bear Valley. One of the important uses of the park will be to function as an outdoor science lab for the students in the Big Bear School System. As Group Conservation Chair, I have conducted presentations on the formation of the pebble plains and their unique plant life for the sixth grade sciences classes at Baldwin Lane Elementary School and the biology class at Big Bear High School. In addition to the presentations, the students have taken field trips to the Sawmill Pebble Plain where they participated in an outdoor curriculum developed by the Big Bear Valley Education Trust.

The wet lands along route 18 where the old outdoor movie theater and real estate office are located, along with the land on the lake side of route 18, has been purchased by the San Bernardino Land Trust with funds from both the federal and state Departments of Fish and Wildlife. This purchase will protect for all times the wetland habitat contained on these properties and the endangered and rare plant species that they call home. The old real estate building will be turned into an outdoor nature center for the students in the Big Bear Valley school system. This will take considerable effort and money which will be the future challenge to those groups that become involved.







Lawsuit Targets Sprawling Southern California Mega-warehouse Project

40 Million Square-foot Logistics Center Will Add 14,000 Truck Trips Per Day, Worsen Pollution, Harm Wildlife

ORENO VALLEY, Calif. — Environmental justice and conservation groups sued the Southern California city of Moreno Valley today over its approval of the World Logistics Center, a sprawling 40-million-square-foot warehouse project that would add 14,000 truck trips to town every day, worsen already poor air quality and harm birds and other wildlife in the nearby San Jacinto Wildlife Area.

The lawsuit follows the South Coast Air Quality Management District, Riverside County Transportation Commission and Riverside County's decision to file lawsuits challenging the warehouse project because of the severe air pollution and traffic problems it will bring to the region.

"To bring this much additional traffic without any mitigation to an area with some of the worst air pollution is criminal," said Penny Newman, executive director of the Center for Community Action and Environmental Justice. "Thousands of studies have demonstrated that air pollution harms people, especially children. Strokes, heart disease, asthma and other respiratory diseases, including lung cancer and even low birth weight and birth defects are linked to air pollution, yet this plan has no mitigation measures in place to address these preventable impacts."

The warehouse project was approved by the city in August 2015. Today's lawsuit

in Riverside County Superior Court challenges Moreno Valley's failure to comply with the California Environmental Quality Act when reviewing the proposed project and its substantial impacts on nearby communities and wildlife. Despite recognizing that the project's significant contributions to worsening air quality, increased traffic congestion and climate change, the city required only meager steps to reduce those harms.

About the size of 700 football fields, the World Logistics Center is expected to generate 400,000 metric tons of greenhouse gas emissions annually and have more than 14,000 truck trips to the site every day. Those trucks would be transporting goods more than 80 miles from the ports of Los Angeles and Long Beach to Moreno Valley, often on two-lane roads that are already congested.

"SR-60, its overpasses, Gilman Springs Road as well as roads within Moreno Valley will become even more clogged and dangerous by the World Logistic Center's more than 14,000 daily toxic diesel truck trips and 50,000 cars," said George Hague, conservation chair of Sierra Club's Moreno Valley Group. "They are not even willing to agree in writing that they will pay their fair share of improvements to these roads as requested several times by

Dirty Air And The Petro-Legislators By Jono Hildner, San Gorgonio Chapter Political Chair

ven before the California legislators returned to Sacramento from their summer recess on August 17, the Sierra Club and other environmental groups were concerned about a small number of Democrats in the San Gorgonio Chapter area who might not be as environmentally friendly as they could be.

Senate Bill 350 had easily passed the Senate by a vote of 24 to 14 on June 3 and moved to the Assembly. This bill, SB 350, was probably the most important piece of environmental legislation to ever be considered by

the California Legislature. In essence, it would have done three things: 1) Require that the Renewable Portfolio Standard (RPS) be increased from 33% in 2020 to 50% in 2030; and 2) Increase the energy efficiency in buildings by 50% by 2030; and 3) Reduce the amount of petroleum used in the state by 50% by 2030.

During the recess, we became concerned that four of our Assembly Members might balk at the 50% reduction in petroleum use and our organizers paid visits to those members' offices to nail down

commitments to vote for SB 350. Asm. Eduardo Garcia, who represents the eastern Coachella Valley and all of Imperial County, was equivocal at first, but after a concerted effort by our organizer, Mina Barragan to get lots of calls, tweets and emails into his office, Garcia saw the light and agreed

to support the Bill. Members Freddie Rodriguez, Jose Medina, and Cheryl Brown were a whole different matter. They were calling themselves "moderate Democrats," but a look at their campaign finance reports showed a whole lot of petro-dollars from a wide variety of sources. They would not commit to support and expressed the same line given to them by Big Oil, that the 50% reduction in petroleum use might help the air, but would place a huge burden on lower income people in their districts and would lead to a huge loss of jobs. They

also claimed that they were getting huge numbers of constituents calling in asking them to oppose, based on the scare tactic TV ads paid for by Big Oil.

That's when Sierra Club of California found some Political Action Committee money to fund Allen Hernandez and his

own neighborhoods. Getting nowhere, they cranked it up several notches.

For example, with 16 activists, in one day, in Cheryl Brown's district, they knocked on 227 doors, gathered 117 petition signatures, put out over 75 lawn signs that included lining the route

Brune sent an email to Kathryn Phillips and our Chapter organizers, thanking them for all their work and suggesting that they had created a model that could be used by other Chapters across the country. While these efforts were not enough to overcome

team of organizers; Mina Barragan in the east Coachella Valley and Jason Martinez in the Metro area. These folks recruited volunteers and jumped on the issue with both feet. They mounted a special effort in each of the districts. They recruited constituents to meet with the member or staff and explain exactly why this legislation was needed. They answered every one of the scary myths promoted by Big Oil and constantly talked about what some of the nation's dirtiest air was doing to the health of the young and the old in their

Cheryl Brown drives from her home to her office. All this in 104 degree weather. They took similar actions in Medina and Rodriguez' districts and before they were done by early September, 85 activists had been involved collecting more than 1000 petition signatures, putting up 250 lawn signs, making 9 office visits and over 250 emails and tweets. All this effort resulted in 21 recorded media hits regarding these efforts.

On September 4, before heading out for a long Labor Day weekend, Michael

the amount of money contributed to those members by Big Oil and the 50% petroleum reduction had to be stripped from the bill, our efforts were recognized by many, both within and outside of the Sierra Club. Enough that the Sierra Club paid for a half page ad that ran in the San Bernardino Sun, calling out Brown, Rodriquez and Medina for putting the interests of the petroleum industry ahead of the health of their own constituents.



560 Miles of Trails!

ne of the best places to lace up a pair of hiking boots and strap on a day-pack is the San Bernardino

National Forest. This is one of the oldest national forests in the United States, having been given special designation more than 100 years ago. It became the San Bernardino National Forest in 1907.

Today, the San Bernardino National Forest is a year-round recreation destination covering 679,380 acres. Two Wilderness areas within

the forest include 11,800 acres at Bighorn Mountain and 56,722 acres that encompass the San Gorgonio Wilderness.

The San Bernardino National Forest has 414 miles of nonmotorized trails within its boundaries, plus 160 miles of the famous Pacific Crest Trail.

Fall is the perfect time to get back to nature in Big Bear. The leaves are turning to fall colors. With fewer people on the trails, the wildlife seems more evident. Hikers

may catch a glimpse of white pelicans, great blue herons, bald eagles, egrets, raccoons, quail, deer, and possibly a black bear.

> For the more adventurous, hike the Cougar Crest Trail, Gold Mountain near Baldwin Lake, Sugarloaf Mountain, Castle Rock near the Big Bear Lake Dam, and Delamar Peak and Grays Peak in Fawnskin. On the south shore of the Lake, hike Big Bear's newest trail, the

Skyline Trail, offering scenic views of the San Gorgonio Wilderness.

Caltrans, Riverside County Transportation Commission and the residents of Moreno Valley."

The World Logistics Center is also adjacent to the San Jacinto Wildlife Area, which is home to many threatened and endangered wildlife and plants, including the Los Angeles pocket mouse, California golden eagle, numerous hawk, raptor and other bird species including the burrowing owl, tricolored blackbird and endangered San Jacinto crownscale. The project area itself is one of the best raptor habitats in the state.

"Birds have already been negatively affected by the glare from the existing warehouses in Moreno Valley. The WLC will increase that impact to another order of magnitude," said Drew Feldmann, conservation chair of the San Bernardino Valley Audubon Society.

"We don't need yet another sprawling mega-project that makes our air dirtier, our climate hotter and our roads more

congested," said Aruna Prabhala, staff attorney at the Center for Biological Diversity. "It's disappointing to see the city of Moreno Valley ignore the impacts this project will have on the climate, wildlife and local residents. They deserve better.

"What is especially disturbing about this project is how its environmental and public health impacts cut across so many areas, and affect so many communities, from air pollution to regional traffic issues, to threatening the habitat of sensitive species," said Yana Garcia, associate attorney for Earthjustice. "We find ourselves with no other choice but to go to court and seek a more thorough environmental review."

Today's lawsuit was filed by Earthjustice on behalf of the Center for Community Action and Environmental Justice, Center for Biological Diversity, Sierra Club, San Bernardino Valley Audubon Society and Coalition for Clean Air.




