## **Next Meeting: "Life in the Lake"**

The next Lake Group general meeting will take place at 7PM on Tuesday May 17, in the Board of Supervisors chamber on the first floor of the Courthouse in Lakeport. Lake County Vector Control District Vector Biologist Bonnie Ryan will guide us through a "living tour" of the complex microscopic life at the base of the food chain in Clear Lake. The program will include live samples of both phyto and zooplankton as well as algae blooms, and promises to provide an unusually fascinating look at a littleknown and uncommonly important subject. When a similar presentation by LCVCD was offered in 2010 every seat was taken and an overflow crowd had to listen from the lobby, so please mark your calendars and plan to arrive early for a good seat.

#### Planning Commission Rejects Middletown Dollar General

On April 28, more than a year after the proposal was first made public (and months after overwhelming opposition from the community led the Commission and Board of Supervisors to reject a similar application in Kelseyville), the Lake County Planning Commission considered an application from Texas-based Cross Development for a Dollar General outlet on Highway 29 just north of central Middletown. Two other Dollar General stores, in Nice and Clearlake Oaks, were approved last year and are now doing business.

Sierra Club comments submitted a year previously reflected our serious doubts about the desirability of this project. Not only does it threaten to impair Putah Creek water quality, interfere with traffic in an area that is already at near gridlock during commute hours, and pose a safety hazard by its location directly across the highway from several schools, many features of the design are profoundly inconsistent with General Plan and Middletown Area Plan policies.

Speaking on behalf of the Club, Lake Group conservation chair Victoria Brandon reiterated those considerations at the April 28 meeting, with support from many members of the community -- and after more than two hours of testimony the Planning Commission denied every one of the requested entitlements by a unanimous vote. An appeal to the Board of Supervisors is anticipated.



\* MAY 8 -- California Native Plant Society **Mothers Day Walk at the McLaughlin Natural Reserve**, led by Reserve co-director Cathy Koehler. The Reserve protects and manages serpentine ecosystems, including serpentine "grasslands" and "barrens" dominated by native forbs. Fine wildflower displays are common, and this year are anticipated to be stunning in the aftermath of the Rocky and Jerusalem fires followed by a wet winter. JUNE 4-5 -- Sierra Club **Yolano Group Snow Mountain hike/car camp.** Snow Mountain is the northern anchor of the newly created Berryessa Snow Mountain National Monument. As one book describes it, "The trip to the twin summits of Snow Mountain offers scenery that includes serene forests of pine and fir, a psychedelic assortment of multihued rocks, and sweeping vistas of mountains and valleys stretching to the far horizons." The 8+ mile roundtrip hike climbing 2200' to the twin peaks above 7000' certainly provides breathtaking views.
